Notes:

- 1. HCS provides Shield Windows and related products and services under our ASME NQA-1 Quality Assurance program.
- 2. Pricing is in USD. Payment is due net 30 days from completion date at site.
- 3. The current estimated lead time for deployment to site is two to four months from receipt of order, based on personnel availability and time required for equipment modifications. Early order placement is recommended for scheduling purposes.
- 4. Start of work for items (1) and (2) are each assumed to commence on a Monday morning. Both items include a 1/2 day maximum training allowance and assume no significant, unexpected interruptions in work flow.

- 5. Triumf shall provide material handling support of HCS specialized equipment from the loading dock to and from the hot cell window as needed.
- 6. Item (1) Shield Window (s/n 592) is to remain in place for service. It is reported to be radiologically clean, and is freely accessible from both the hot and cold sides. There is no Barrier Shield installed that would inhibit access to the hot side cover glass.
- 7. Item (2) Shield Window (s/n 593) is reported as radiologically contaminated. Triumf shall provide the necessary isolation tent, PPE equipment and decon support required to assure performance of the oil and gasket change.
- 8. Performance of item (2) includes two separate visits to Triumf, each commencing on a Monday morning. The first visit includes training, on-site deployment, erection of the work table and extraction of the window onto the table. The second visit occurs after completion of Triumf decon efforts. This visit includes the oil and gasket change, leak testing, re-installation of the window, and equipment teardown and packing for removal from site.
- 9. Disposal of all job related debris and contaminated materials is Triumf's responsibilty.
- 10. The use of HCS specialized equipment includes rental of a specialized, high capacity table. If the table becomes contaminated, and Triumf decon efforts are unsuccessful, the table disposal will be Triumf's responsibility, and a \$3,700 table abandonment charge will be assessed. The abandonment charge is based on a \$6,500 valuation less rental charge and return shipping.
- 11. This quotation is valid for 90 days.
- 12. Standard Terms and Conditions are attached.

TERMS AND CONDITIONS OF SALES

GLASS ACCEPTANCE STANDARDS

Unless otherwise specified by customer's Purchase Order and Specifications, all glass sales shall meet the following quality standards:

Flat Glass - ASTM C 1036-01 Q3

Laminated Flat glass – ASTM C 1172-03 and ASTM C 1036-01 Q3

X-ray Flat Glass - ASTM C 1036-01 Q3

Radiation Shielding Glass - UK AESS 44 70000 6

PURCHASE ORDER:

An original, faxed or emailed copy of PURCHASER'S Purchase Order must be received by SELLER prior to commencement of any design or production activity.

MINIMUM CHARGE:

A minimum order charge of USD \$500 applies to all orders placed with SELLER.

TAXES:

SELLER's prices do not include sales, use, excise or similar taxes. Thus, in addition to the price specified herein, any present or future sales, use, excise or similar taxes applicable to the products sold here under shall be applied to the price and paid by the Purchaser.

PAYMENT TERMS:

Net cash, thirty (30) days with approved credit, unless specifically amended by the Purchase Order. In the event that SELLER incurs costs and expenses, including but not limited to attorneys' fees, to collect sums due hereunder or to otherwise enforce its rights hereunder, such costs and expenses shall be paid by the PURCHASER. In the event that payment is not made when due, a late charge equal to the lesser of 18% or the highest legal rate permitted by law shall accrue on such unpaid amounts.

DELIVERY TERMS:

F.O.B. FACTORY, FREIGHT PRE-PAY AND ADD, unless otherwise agreed in writing. In all cases, risk of loss or damage to goods in transit shall fall to the PURCHASER, who shall file any resulting claims with the carrier. SELLER shall not be liable for delay in delivery due to causes beyond its reasonable control. For Export orders, shipment date is subject to extensions of time as required to obtain any necessary export licenses. SELLER reserves the right to make partial shipments unless other instructions are given.

CANCELLATION:

PURCHASER may cancel an order provided written notice is given to SELLER prior to the commencement of manufacture. If manufacturing has started, including any engineering and tooling costs, SELLER shall charge the full invoice price.

PATENTS:

PURCHASER shall hold SELLER harmless against any expense and loss including attorneys' fees, from infringement of patents or trademarks arising from compliance with PURCHASER'S designs, specifications or instructions in the manufacture of the products.

All glass refurbishment work will be performed on "Best Effort" basis without any liability for potential damage during the refurbishment process.

NUCLEAR INDEMNIFICATION:
